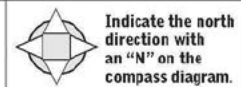

NARRATIVE
Unit 1 and Unit 2 were both traveling south on Fishcreek Rd approaching Kent Rd. Both Unit 1 and Unit 2 were stopped at a red light at the intersection. According to Unit 1, they were in the furthest left turn lane, and Unit 2 was in the second furthest left turn lane. Unit 2 then came into unit 1 lane and struck their vehicle. According to Unit 2, they were in the furthest left turn lane. Unit 2 then appeared on the right side of their car and struck their vehicle. Unit 2 did not see Unit 1 in any of the lanes on Fishcreek Rd. Due to conflicting statements, no citation was issued.
