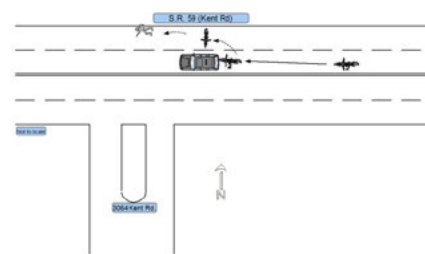
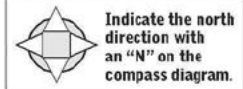

NARRATIVE

Unit #1 was traveling Westbound on S.R. 59 (Kent Rd.), near 3064 Kent Rd. Unit #1 was slowed in traffic and about to conduct a left hand turn into the drive of 3064 Kent Rd. Unit #2 was also traveling Westbound on S.R. 59 (Kent Rd.). Unit #2 failed to maintain assured clear distance and struck Unit #1, causing damage to both vehicles. The operator of Unit #2 was ejected from the vehicle and came to a rest in the roadway. Serious injuries suspected.

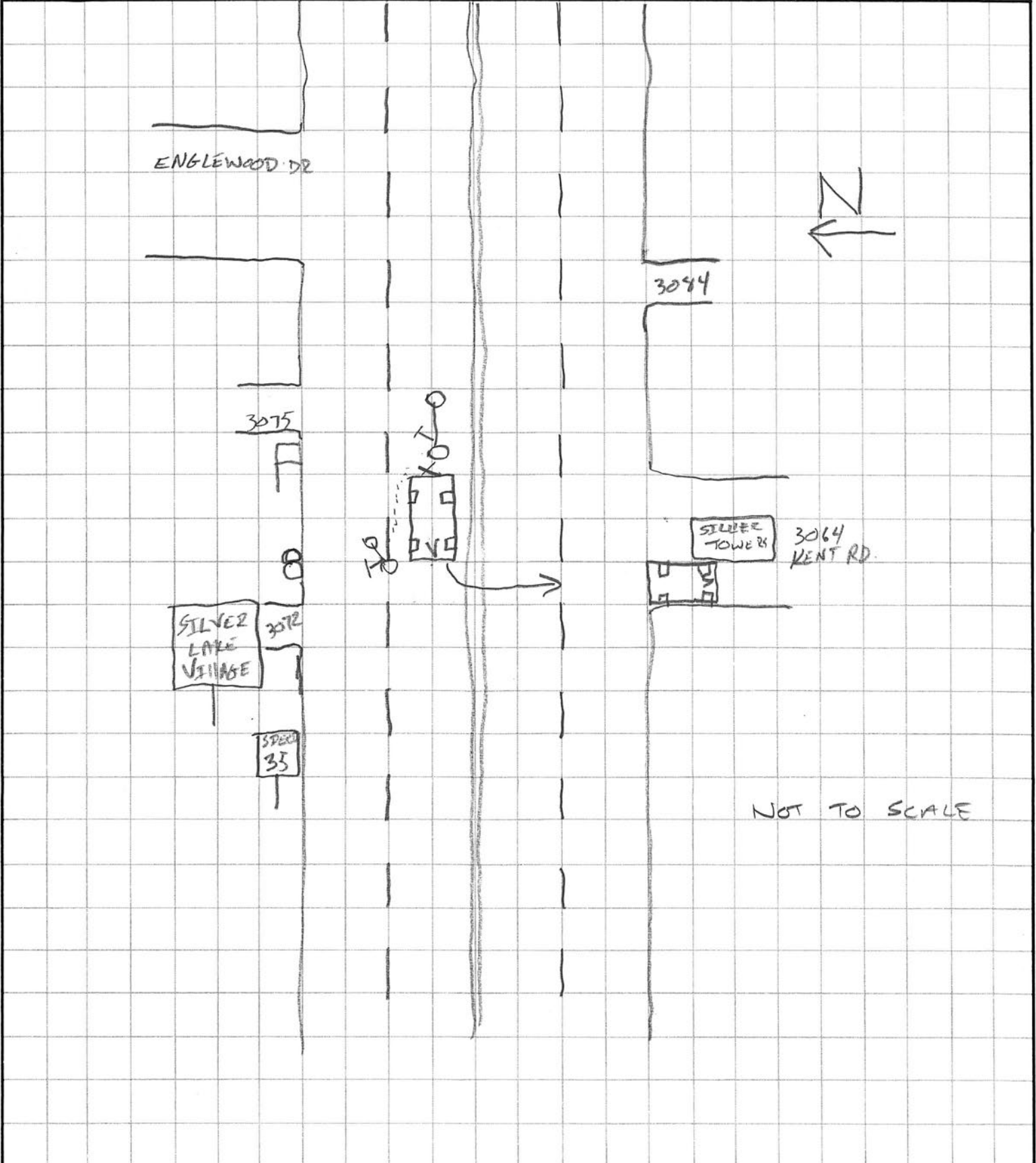



